 - ④ prove to have registered with the relevant authorities, in accordance with the Pharmaceutical Affairs Law, to initiate business of selling medical appliances;
 - ⑤ prove to have prepared a system to provide rapid after-sale service and maintenance for the procured products.
 - ⑥ meet the qualification requirements which the Obligating Officer may specify in accordance with Article 4 of the Reg-
